**IT IS THE FURTHER ORDER OF THE COURT THAT YOU SHALL COMPLY
WITH THE TERMS AND CONDITIONS WHICH ARE MARKED [X] AS FOLLOWS:**

- 1. You shall not violate any criminal statute or ordinance of any jurisdiction, including traffic violations and legal curfew, as follows:

Sunday through Thursday — 11:00 p.m. to 6:00 a.m.
Friday/Saturday — 12 midnight to 6:00 a.m.

- 2. You shall report to or appear in person before the Probation Officer within 7 days and further as the Probation Officer shall direct.

- 3. You shall permit the Probation Officer to visit you at your home or elsewhere to the extent necessary to discharge the Officer's duties. You shall advise the Probation Officer as to your residence, phone number, school, and employment. You shall notify the Probation Officer within 2 days as to any change.

- 4. You shall not have in your body the presence of any alcohol or illicit drug prohibited by the Cannabis Control Act (720 ILCS 550/1) or the Illinois Controlled Substance Act (720 ILCS 570/100) unless prescribed by licensed physician and shall submit to any random alcohol or drug testing ordered by the Probation Officer and pay cost thereof, and shall undergo any substance abuse counseling or treatment directed by the Probation Officer and pay any cost thereof.

- 5. You shall undergo an alcohol and drug assessment by _____ or a licensed agency approved by the Probation Officer and, if required by said agency or the Probation Officer, complete a remedial education course and/or an alcohol and drug evaluation, counseling, or treatment as an inpatient or outpatient for the period of time required by said agency or the Probation Officer. You shall report to said agency within 7 days and further as said agency or the Probation Officer shall direct and pay all costs thereof;

- 6. You shall pay court costs of \$ _____ according to the following schedule: \$ _____ per _____, beginning _____ to be paid in full within _____ as per "Pay or Appear Order" attached. All payments shall be made to the Circuit Clerk.

7. You shall not possess a firearm or other dangerous weapon and shall surrender to the Clerk of the Court your Firearm Owners Identification card for the term of this Order.
8. You shall not leave the State of Illinois without the consent of the Court or, in circumstances in which the reason for the absence is of such emergency nature that prior consent by the Court is not possible, without prior notification and approval of your Probation Officer.
9. You shall undergo a psychological assessment by _____ or a licensed facility approved by the Probation Officer and, if required by said facility or the Probation Officer, complete psychological evaluation, counseling, or treatment as an outpatient for the period of time required by said facility or the Probation Officer and shall pay all cost thereof.
10. You shall serve a term of home confinement at _____ or any location subsequently approved by the Probation Officer for a period of _____ beginning _____ from _____ until _____ each day. You shall remain within the interior of the place designated for your confinement during the hours designated and shall not leave your confinement except for the reasons set forth on the attached "**Conditions of Release from Home Confinement/Custodian's Home.**"
- As part of this home confinement, you shall be placed on an approved monitoring device as provided by law with your consent and/or consent of the other person in residence with you and shall comply with the terms and conditions of an agreement with _____ and shall pay all cost thereof, according to the following schedule: Initial charge of \$ _____ within 7 days and _____ per _____ beginning _____ and continuing on the same day of each _____ thereafter until home confinement is terminated.
- You shall admit the Probation Officer into your place of confinement at any time for the purpose of verifying your compliance with the conditions of your confinement.
11. You shall participate in and complete the requirements of the _____ program and shall report to said program as _____ or the Probation officer shall direct and pay all cost thereof.
12. You shall not contact, directly or indirectly, be in the presence of, or go upon the premises of _____.
13. You shall become and remain gainfully employed by _____ or by an employer approved by the Probation Officer for at least _____ hours per week beginning _____ and shall present satisfactory evidence thereof to the Probation Officer.
14. You shall pursue and complete a course of study or vocational training at _____ or an institution approved by the Probation Officer beginning _____ and shall present satisfactory evidence thereof to the Probation Officer.
15. You shall not acquire a driver's license, or if you are in possession of a driving permit or license, you shall not drive or operate any motor vehicle, except as may be necessary in the course of your lawful employment, and shall surrender the driving permit or license to the Clerk of the Court for a period of _____. (Alcohol, cannabis, or controlled substance violations only.)
16. You are sentenced to a term of _____ as set forth in the Order attached hereto;
17. You shall submit to Genetic Marker Group (DNA) and HIV blood testing as set forth in the Order attached hereto. You shall provide specimens of blood, saliva or tissue for genetic marker grouping analysis as required by 730 ILCS 5/5-4-3. You shall pay to the clerk of the court an analysis fee of \$200.00 and any cost for obtaining the specimen.
18. You shall participate in and complete the requirements of a non-residential program for youth at _____ or at a program approved by the Probation Officer beginning _____ and further as said agency or the probation officer shall direct and shall pay all costs thereof.
19. You must participate in and cooperate with any and all programs and agencies to which you are referred by the Probation Officer.
20. You shall make restitution of \$ _____ to _____ according to the payment schedule set forth in Paragraph 6.

- The Respondent parent _____ is ordered to pay \$ _____ on behalf of the minor toward this Court-ordered restitution, pursuant to the Parental Responsibility Law (740 ILCS 115/5), according to the payment schedule set forth in Paragraph 6.

A judgment for this amount is entered in favor of said victim. The Circuit Clerk shall enter this judgment in the judgment docket.

21. You shall perform public service work under the direction and supervision of _____ or the Probation Officer for a period of _____. You shall abide by all the rules and responsibilities of the community service program of the _____ County Probation Department. You shall not be entitled to any compensation therefore and shall not be considered an employee for any purpose, including worker's compensation coverage;

22. You shall reside with _____ and shall obey and abide by all household rules and regulations during the term of this Order. You are not to leave such residence overnight for any purpose, unless you have the express permission of your parent, guardian or custodian.

- You shall obey a special curfew for a period of _____ beginning _____ from _____ until _____ each day. You shall remain in your residence during the hours designated and shall not leave except for the following reasons: _____

23. You shall enroll and shall complete the requirements of the study program for preparation for the test for a General Education Diploma (GED). You shall obtain a (GED) within _____ or as required by the Probation Officer.

24. You shall attend school regularly and obey and abide by all school rules and regulations during the term of this Order, unless the Probation Officer approves an alternate educational plan in writing. You must not be tardy or truant. You must notify the Probation Officer by 10:00 a.m. on any day that you are absent or must secure permission from the Probation Officer before checking out of school prior to dismissal. **The Clerk is ordered to provide a copy of this Order to your school.**

25. A Review Hearing is set for _____ at _____ when you shall appear and the Court shall review the terms and conditions required to be met in this Order. If all terms and conditions are met, then you shall not be required to appear at the Review Hearing.

26. IT IS FURTHER ORDERED that you shall be subject to the Administrative Sanctions Program established by the Chief Judge of the Second Judicial Circuit. The Probation Department may invoke any sanction of this Program for violation of the terms and conditions of this Order.

27. IT IS FURTHER ORDERED that, having considered your ability to pay, a probation fee of \$25.00 for each month of actively supervised public service work, probation, conditional discharge, or supervision is imposed upon you as costs.

28. IT IS FURTHER ORDERED that at the conclusion of the term of supervision/Section _____ probation, if the Court determines that you have successfully complied with all of the terms and conditions of this Order, the Court shall enter a judgment dismissing this cause.
