**ADDITIONAL CONDITIONS OF BAIL BOND**

The Defendant has been admitted to bail pursuant to a bail bond to which these additional conditions of bail bond are attached. Pursuant to 725 ILCS 5/110-10, the Court imposes the following additional conditions of bail:

1. You are placed under the direct supervision of the Probation Department and shall report to or appear in person before the Probation Officer within 24 hours and further as the Probation Officer shall direct.

2. All firearms owned or in the possession of the Defendant shall be surrendered to the \_\_\_\_\_ County Sheriff and held until the Defendant is released from this bail bond.

3. The defendant shall refrain from possessing a firearm or other dangerous weapon and shall surrender to the Clerk of the Court his Firearm Owners Identification card for the term of this bail bond.

4. The defendant shall not approach, contact, communicate, be in the presence of, or go upon the premises of \_\_\_\_\_.

5. The defendant shall not have in defendant's body the presence of any alcohol or illicit drug prohibited by the Cannabis Control Act (720 ILCS 550/1) or the Illinois Controlled Substance Act (720 ILCS 570/100) unless prescribed by licensed physician and shall submit to any random alcohol or drug testing ordered by the Probation Officer and pay cost thereof, and shall undergo any substance abuse counseling or treatment directed by the Probation Officer and pay any cost thereof.

6. The defendant is placed in the custody of \_\_\_\_\_ who appears in open Court. By executing this bail bond, said custodian acknowledges and agrees to supervise these conditions of the defendant's release. As a condition of defendant's release, defendant shall remain within the interior of the custodian's residence located at \_\_\_\_\_ and shall not leave the custodian's residence except for the reasons set forth on the attached "**Conditions of Release from Home Confinement/ Custodian's Home.**" Said custodian \_\_\_\_\_ agrees to monitor defendant's release and be responsible for notifying the Court if the defendant fails to follow these conditions of release. Further, said custodian shall be subject to contempt of Court for failure to notify the Court if you fail to follow these conditions of release.

7. The defendant shall undergo an alcohol and drug assessment by \_\_\_\_\_ or a licensed agency approved by the Probation Officer and, if recommended by said agency or the Probation Officer, complete a remedial education course and/or an alcohol and drug evaluation, counseling, or treatment as an inpatient or outpatient for the period of time required by said agency or the Probation Officer. The defendant shall report to said agency within 7 days and further as said agency or the Probation Officer shall direct and pay all costs thereof;

8. The defendant shall undergo a psychological assessment by \_\_\_\_\_ or a licensed facility approved by the Probation Officer and, if recommended by said facility or the Probation Officer, complete psychological evaluation, counseling, or treatment as an outpatient for the period of time required by said facility or the Probation Officer and shall pay all cost thereof.

9. The defendant shall pursue and complete a course of study or vocational training at \_\_\_\_\_ or an institution approved by the Probation Officer beginning \_\_\_\_\_ and shall present satisfactory evidence thereof to the Probation Officer.

10. The defendant shall participate in and complete the requirements of the \_\_\_\_\_ program and shall report to said program within \_\_\_\_\_ days and pay all costs thereof.

11. The defendant shall support his dependents as required by law and, in addition, as required in case number \_\_\_\_\_ and shall present satisfactory evidence thereof to the Court/Probation Officer;

12. The defendant shall attend school regularly and obey and abide by all school rules and regulations during the term of this bail bond. You must not be tardy or truant. You must notify the school by 10:00 a.m. on any day that you are absent or must secure permission from the school before checking out of school prior to dismissal. **The Clerk is ordered to provide a copy of this Order to your school.**

13. The Defendant's access to the child victim \_\_\_\_\_ is restricted as follows:

a. Defendant shall vacate the household of said child victim.

b. Defendant shall pay temporary support for his dependents in the amount of \$ \_\_\_\_\_ beginning on \_\_\_\_\_, said temporary support payments shall be made through the Circuit Clerk's Office.

c. Defendant shall refrain from any contact or communication with the child victim except as ordered by the Court.

14. The defendant shall serve a term of home confinement at \_\_\_\_\_ or any location subsequently approved by the Probation

Officer for a period of \_\_\_\_\_ beginning \_\_\_\_\_ from \_\_\_\_\_ until \_\_\_\_\_ each day. The defendant shall remain within the interior of the place designated for his confinement during the hours designated and shall not leave his confinement except for the reasons set forth on the attached "**Conditions of Release from Home Confinement/Custodian's Home.**"

As a part of being placed in home confinement/custodian's home as set forth above, the defendant shall be placed on an approved monitoring device as provided by law with the consent of the defendant and/or other person in residence with him and shall comply with the terms and conditions of an agreement with \_\_\_\_\_ and shall pay all cost thereof, according to the following schedule: Initial charge of \$\_\_\_\_\_ within 7 days and \_\_\_\_\_ per \_\_\_\_\_ beginning \_\_\_\_\_ and continuing on the same day of each \_\_\_\_\_ thereafter until home confinement is terminated.
